The True & Better Adam (Pt. 2) Romans 5:12-21

- Adam our Representative: How Sin, Condemnation & Death Came to All Men (12-14)
 - A. Adam's Representation Explained (12)
 - 1. Sin Entered the World through Adam (12a).
 - 2. Death Entered the World through Adam's Sin (12b).
 - a. Physical Death
 - b. Spiritual Death
 - c. The Second Death
 - 3. Death Spread to All Men because of Adam's Sin (12c).

"All Sinned": Four Primary Views

- 1) The Pelagian view (Pelagius)
 - a) We inherit NO moral corruption from Adam through our parents and are born without a sin nature [heresy].
 - b) We bear no personal guilt for Adam's sin.
 - All sinned: "We choose to sin, because we choose to follow Adam's bad example."
- 2) Inherited Sinful Nature view (Calvin)
 - a) We inherit moral corruption from Adam through our parents.
 - b) We bear no personal guilt for Adam's sin.
 - All sinned: "We have all committed personal sins, because we inherited moral corruption from Adam through our parents."

"All Sinned": Four Primary Views

- 3) Seminal or Realism view (Augustine)
 - a) We inherit moral corruption from Adam through our parents.
 - b) We bear <u>personal guilt</u> for Adam's sin—because we were *really or seminally* in Adam.
 - All sinned: "We all sinned in Adam, because we were in his loins when he sinned."
- 4) Representative Headship view (Reformed)
 - a) We inherit moral corruption from Adam through our parents.
 - b) We bear <u>personal guilt</u> for Adam's sin—because God appointed *Adam* as our federal head or representative.
 - All sinned: "We all sinned in Adam, because God appointed him as our representative."

The Key Similarities between Adam & Christ

- 1. God appointed both as representatives.
- 2. God appointed both over their "seed" or descendants.
 - Adam his physical seed
 - Christ his spiritual seed
- 3. God appointed both as the only two representatives of humanity.
- 4. God credits the results of the work of both to their seed.
 - Adam sin, condemnation, and death
 - Christ righteousness, justification, and eternal life
