"Let us make man in our image, after our likeness... Genesis 1:26


When God created man, He made him in the likeness of God, male and female He created them, and He blessed them and named them Man when they were created. Genesis 5:1

Those "works," declared "great," are "studied" works by "delighting" believers. That truth was the central verse in what became known as "The Scientist's Psalm." In the work of *dominion* & *subduing*, believers will *delight* in their study of "the works of Yahweh."
















Throughout the universe we see a lawful ordering (cosmos means order... in contrast to chaos) ...we see order, precision, beauty, elegance, simplicity, harmony, symmetry in ... **A Mathematical ordering** In Physics, Chemistry, Optics In Biology... e.g. DNA, cellular function, organism ...in Music ... e.g. octaves, chords, keys, rhythm

Science means "knowledge."

God is all-knowing – man is not.

The classic scientific endeavor . . . the searching out of knowledge to understand God's works, to discover and utilize the <u>provision</u> found in creation, and to develop the discovered science into technology for the <u>good of man</u> and <u>the glory of God</u>.

Scientific endeavor is a category of subduing and exercising dominion!

...delighting in the studied works of the LORD!

Classic BIBLICAL PRESUPPOSITIONS IN SCIENCE

- 1) Rational & knowable ordering in creation
- 2) <u>Precision</u> in the ordering
- 3) Lawful <u>Contingency</u>

Testimony of Isaac Newton... Along with science, Newton pursued his other great love — studying the Bible.

"I have a fundamental belief in the Bible as the Word of God, written by men who were inspired. I study the Bible daily."

Among his publications was:

"Chronology of Ancient Kingdoms and Observations Upon the Prophecies of Daniel".

Testimony of Louis Pasteur . . .

Pasteur saw no conflict between science and Christianity. In fact, he believed that *'science brings men nearer to God'*. In his work as a scientist, he perceived evidence of wisdom and design, not randomness and chaos.

Pasteur quoted as, "The more I study nature, the more I stand amazed at the work of the Creator."

Known for the formulation of the *law of biogenesis* — that life comes from life — **Testimony Concerning James Clerk Maxwell ...** ... Designed and constructed the Cavendish Laboratory at Cambridge.

Carved in the heavy wooden doors of the laboratory's entrance is Psalm 111:2 in Latin:

"Great are the works of the LORD, studied by all who delight in them."

Testimony Concerning James Clerk Maxwell...

A written prayer found after his death . . . "Almighty God, who created man in Thine own image, and made him a living soul that he might seek after Thee and have dominion over Thy creatures, teach us to study the works of Thy hands, that we may subdue the earth to our use and strengthen the reason for Thy service; and so to receive Thy blessed Word, that we may believe on Him Whom Thou hast sent to give us the knowledge of salvation and the remission of sins. All of which we ask in the name of the same Jesus Christ, our Lord."

There is a [intelligible, *discoverable and immutable*] lawfulness of nature and a stunning provision of the created *order* in that lawfulness.

God has granted mankind an amazing ability and sense of duty to observe, contemplate, search, explore, discover, evaluate, develop, and utilize that provision.

In that His lawful ordering we see goodness, beauty, and righteousness (laws lead to consequences). The lawfulness is accessible to human understanding. The greatest in the "Age of Science" were driven by their faith and grounded in a biblical understanding of God's work of creation and the lawful provision therein. "Great are the works of Yahweh, studied [sought] by all who delight in them"

The Battle of Worldviews

Why, then, is there the perceived conflict between science and the Bible?

How did it come to be?

... "Did God actually say, ... (Genesis 3:1)

In those days there was no king in Israel. Every man did what was right in his own eyes. (Judges 21:25) Considering contemporary myths, lies, and "cancel culture"

- The church killed Greek science – false
- Christianity plunged Europe into the "dark ages" – false
- Columbus vs the church's 'flat earth' – false
- The inquisition of Galileoscience vs Scripture – false



Considering myths, lies, and "cancel culture"

- Portrayal of superstition, intolerance, tyranny – false
- Progressive science and 'reason' freed us from the regressive religion – false



Considering myths, lies, and "cancel culture"

 The Enlightenment brought us out of the Dark Ages and spurred the Scientific Revolution and the Renaissance.
 —propaganda with purpose!

The Legacy of Darwinian theory began way before...

- Deist James Hutton (1726-1797) who thought religion as contrived . . . Supposed earth millions of years old with gradual changes; also suggested "continuous evolution"

Friends with evolutionist **Erasmus Darwin** (1731-1802)

- Geologist <u>Charles Lyle</u> (1797-1895) influenced by Hutton, popularized uniformitarianism.
 - Atheist Thomas Huxley (1825-1895) dubbed "Evolution's High Priest. Portrayed theology as "enemies of science." Coined "survival of the fittest." Very influential in all public spheres.

But it was the "<u>Conflict Thesis</u>" that really popularized the "conflict" between Scripture and science . . .

John William Draper (1811-1882) and Andrew Dickson White (1832-1918) were American scientists and educators who were friends with and highly influenced by Thomas Huxley and others in the close circle of British atheists.

Draper published a book in 1874 entitled, "A History of the Conflict between Religion and Science" positing the "progressive power of science" and the "regressive and repressive power of religion."

White was the founding president of Cornell University, declared that Cornell would be "an asylum for Science – where truth shall be sought for truth's sake, not stretched or cut exactly to fit Revealed Religion." In 1896, White published "A History of the Warfare of Science with Theology in Christendom" with the thesis that Christianity had always been at war with science. The problem . . . both *Conflict* and *Warfare* were found to be fabricated as works of history, and widely rejected by historians. But the "war" image has survived in popular ... a very successful propaganda campaign! thinking.

"... men, who by their unrighteousness suppress the truth." (Romans 1:18b)

Paul's warning to Timothy: *"Avoid the irreverent babble and contradictions of what is falsely called 'knowledge.""* (1 Timothy 6:20)



"But where shall wisdom be found? And where is the place of understanding?" (Job 28:12)



"Behold, the fear of the Lord, that is wisdom, and to turn away from evil is understanding."(Job 28:28)"For whoever finds [wisdom] finds life." (Prov 8:35)

"All things were made through [Jesus Christ], and without him was not any thing made that was made. In Him was life." (John 1:3-4)

> "... Christ, in whom are hidden all the treasures of wisdom and knowledge." (Colossians 2:3)

No body of thought contributed more to scientific thinking than the presuppositions and central tenets of the Christian faith.

The "conflict" is a misconceived lie. There is NO conflict!

Scientific endeavor flourishes in the soil of biblical presuppositions and the moral sanction given by the dominion mandate.

Oh... to know Christ, and to be found in Him!

There is a beautiful, discernable, [fixed], and useful order in the universe accessible to the mind of created man, who bears the image of the rational Creator and is endowed with intelligence. Man is equipped and commissioned to seek out that order. One found in Christ *delights* in the study of His works so to know his Creator and to make Him known. In that sense, we are all scientists!

Bearing GOD'S Image . . . What are the implications? Reflecting . . .

- We appreciate and see beauty and majesty in creation.
 God is ultimate beauty.
- We experience awe and wonder. Wonder demands God as its explanation.
- We are creative, in the likeness of the Creator. We think . . . and, in response, we do. We contemplate and act with purpose . . . with design . . . with an end in mind.

Reflecting . . .

- Foundationally, image indicates that man has a relationship and spiritual fellowship with God. Man needs relationship.
- Unique from animals . . . made in the image and likeness of our Creator.

btw, the <u>new man</u> reestablishes what was damaged in the fall. (Eph 4:24; Col 3:10)

- Bearing His Image and Likeness, we relate to Him. We are His sons and daughters – as His creatures – but because of the fall, rebelling, estranged, separated, at enmity with our Creator.
- In Christ redeemed we are atoned for and forgiven, brought back into the family, given access to the King. Our redemption also renews these substantive components of our being . . .
 - Personality is central because our personality is grounded in His infinite personality. We are given . . .
 - A mind with the ability to reason, remember the past, contemplate the future, and apply that understanding to the present – we have an intellect with a will.

The ability to think and communicate in the abstract, to articulate in complex speech

- A self-awareness a conscience with a moral sense operating to guide or convict us.
 We have an awareness of a moral order.
 - A capacity to make decisions ("free" will, we possess self-determination), acting out of our own character . . . our own nature
 - Creativity, ingenuity a sense of comprehension of meaning and significance

An appreciation of beauty,
 goodness, and truth, which motivates
 our pursuit to know our Creator

All of these characteristics of our personhood, along with the very contemplation of the creation around us, give testimony to bearing the image of God!



God *spoke* the cosmos into existence ... with a nature consistent with His character ... and He is constantly involved in the unfolding pattern of the ongoing operation of the universe.

For thus says the LORD, who created the heavens (He is God!), who formed the earth and made it; He established it; He did not create it empty, <u>He formed it to be inhabited</u>! – He says: "I am the LORD, and there is no other." Isaiah 45:18 And the earth was **formless** and **void**, and darkness was over the surface of the deep . . . Genesis 1:2

"formless" [Heb: tohu] = "without form" > emptiness, waste, place
of chaos (e.g., in vain, without purpose);
"void" [Heb: bohu] > emptiness, waste, nothingness

... can be described as "bare being;" "lacking differentiation;" Considering Isaiah 45, Genesis 1:1-2 can be paraphrased as, *"the heaven and earth were created, at first, unformed and uninhabited."* But then, differentiation took place; He filled it and formed it . . . in time [we could say, "He **ordered** it" \rightarrow ... the light separated from the darkness (v4) ... the expanse separating the waters below from the waters above (v7) ... gathering of waters and land (v9) ... vegetation, plants vielding seed, fruit trees bearing fruit (v11) ... two great lights, sun & moon, (and the stars), separating day and night (vv14-16) ... conscious and unconscious life (vv20-21); water creatures, air creatures, land creatures ... created life and procreated life (vv22-25)

... With the habitation prepared, man is set apart, bearing the image of the Creator; and further differentiated male and female. (v26-27)

How Does Science Fit into All of This?

Back to Genesis 1:26b . . . made in the image and likeness of God, ". . . and let them have dominion . . ."

Later in vs. 28 . . . "And God blessed them. And God said to them, 'Be fruitful and multiple and fill the earth and subdue it, and have dominion . . ."

Implications of *dominion*:

... delegated physical responsibility to cultivate and care for

 a stewardship
 delegated moral responsibility
 given provision for usefulness
 the animals brought to Adam to be named (2:19-20)

(Read Psalm 8:5-8 for a striking expression of man's dominion.)

Science means "knowledge."

God is all-knowing – man is not.

The scientific endeavor is . . . the searching out of knowledge to understand God's works, to discover and utilize the provision found in creation, and to develop the discovered science into technology for the good of man and the glory of God.

Scientific endeavor is a category of **subduing** and exercising dominion!

The fear of the Lord is the beginning of knowledge. (Prov 1:7)

Known as the **Dominion Mandate** or **Cultural Mandate**

... which calls for an intense study of the earth (with all its complexity of components and processes) and then, the utilization of this knowledge for the benefit of mankind. This calling is what authorizes both science and technology as a basic enterprise (derived from "working and keeping" the garden).

"Science" is the disciplined study and understanding of the phenomena of his world.

"Technology" is the implementation of this knowledge in the effective ordering and development ("creating out of something") of creation's resources for the greater good... and for the glory of God!

The Testimony of the Logos (John 1:1-18)

John's themes in the prologue...

providing testimony and giving witness life (not biological but spiritual) light revealed glory No one has ever seen God; the only God, who is at the Father's side, He has made Him known. John 1:18

In the beginning was the Word [logos], and the Word was with God, and the Word was God. He was in the beginning with God. All things were made through him, and without Him was not any thing made that was made. John 1:1-3 Logos means word, but it had a far deeper meaning in the culture John was writing to to the Jews ... and to the Greeks First, to the Jews . . .

Logos to the Jewish mind would call to mind . . . The Word of God.

God *spoke* the creation into existence . . . "And God said . . ." repeated over and over in Genesis 1

For the word of the Lord is right and true . . . By the word of the Lord the heavens were made, and by the breath of His mouth all their hosts. Psalm 33:4,6

Your word is a lamp for my feet, and a light on my path.

Psalm 119:105

... to the Jewish mind ...

You are my refuge and my shield; I have put my hope in your word. Psalm 119:114

So is my word that goes out from my mouth: It will not return to me empty but will accomplish what I desire and achieve the purpose for which I sent it. Isaiah 55:11

See also Ephesians 6:17, 1 Peter 1:23, Hebrews 1:3,

... to the Jewish mind ...

Logos is also related to wisdom . . . For the LORD gives wisdom; from His mouth come knowledge and understanding. **Proverbs 2:6** The unfolding of your words gives light; it gives understanding Psalm 119:130 to the simple. Therefore, everyone who hears these words of mine and puts them into practice is like a wise man who built his house on the Matthew 7:24 rock.

To the Jewish mind, then . . .

In his opening prologue, John was pronouncing that the God-man, Jesus Christ, was the full revelation of God!

... the promised Word of God, made known (explained; Gk exegeomai, to exegete)

See John 3:31-36; 12:45; 14:8-10

Logos to the Greek mind carried a completely different concept . . .

Heraclitus (6th century BC) referred to the concept of the cosmic process or rationality – a logos – analogous to the reasoning power in humans.

Pythagoras developed the concept to include 3 components: The *whole* or singular; the *diversity* or many; and the *harmony* or relationship of one to another. ... to the Greek mind *logos* meant ...

... rationality, intelligence, [that communicates]; a unifying principle of the cosmos giving it form & meaning. It was a central concept for the Stoics – the rational order. The world soul.

Stoicism emphasized that the entire universe was ordered according to the wise direction and the rational principles of the *logos*.

Logos is, thereby, related to wisdom, in that it had both the power of reasoning and was reason expressed in speech.

To the Greek mind, then . . .

In his opening prologue, John was pronouncing that the impersonal rationality and unifying principle of the universe was a Person, infinite, eternal, and triune, Who had created all things, and now, has revealed Himself in his work of redemption!

"What therefore you worship as unknown, this I proclaim to you. The God who made the world and everything in it . . ." Acts 17:24

Jesus Christ is the Logos . . . the locus of God's self-disclosure ... the "I am" who declares, "Let there be light." It is through the [dynamic, powerful, and personal] Logos that God 'unveils himself.' This Logos is the agent & mediator of both creation and redemption. The Logos is Truth and brings truth, disclosed in witness and testimony . . . the light which illumines.

Then Pilate said to Him, "So you are a king?"

Jesus answered, "You say that I am a king. For this purpose, I was born and for this purpose I have come into the world — to bear witness to the truth. Everyone who is of the truth listens to my voice.

Pilate said to him, "What is truth?"

John 18:37-38

... To bear witness – to the TRUTH!
